COMPLAINANT, BEVINGTON, WHO STATED THAT WHEN HE ARRIVED ON SCENE
AT APPROXIMATELY 0200 ON 3/21/08, HE FOUND THAT THE DOOR AT THE
REAR OF THE BUSINESS WAS STANDING OPEN. UPON INSPECTING THE
INSIDE OF THE BUSINESS HE FOUND THAT SEVERAL COMPUTER TOWERS AND
MONITORS HAD BEEN TAKEN HOWEVER AT THE TIME HE COULD NOT SAY FOR
SURE HOW MANY. OFFICER MUSSELMAN OBSERVED THAT THE FRONT DOORS TO
